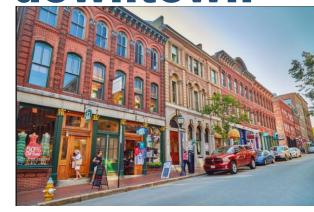
# **RECOMMENDATION:**

- September 2019 State authorizes consideration of Incentives
- November 2019 Gov. Cooper announces Well location in Chapel Hill

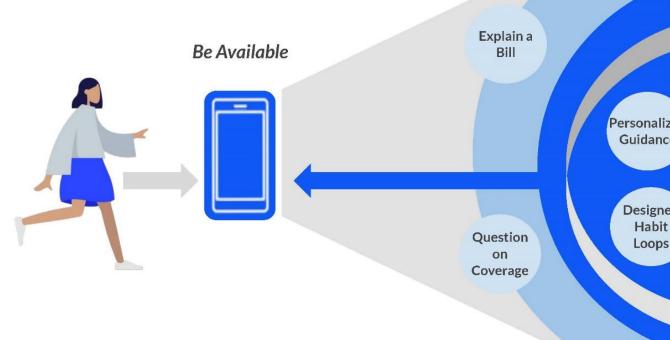


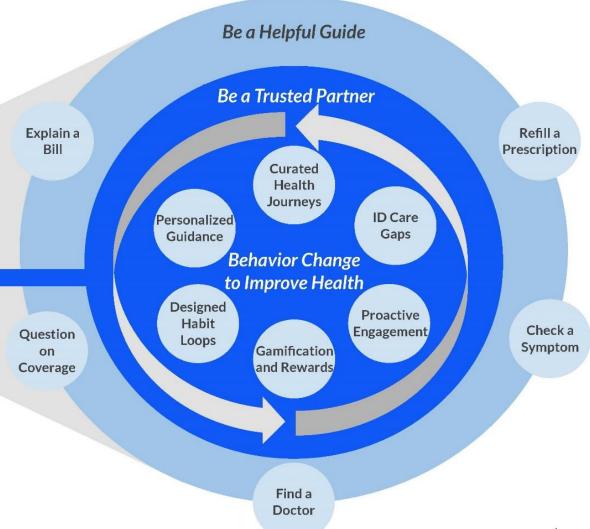

# Incentive

- \$900,000 total package
- \$450,000 is a cash grant after two years of employment reporting
- \$450,000 is a parking credit used in \$56,000 increments annually over the eight years.
- Award based on Incentive Guidelines
