## THE ORANGE COUNTY LOCAL GOVERNMENT AFFORDABLE HOUSING COLLABORATIVE INVITES RESIDENTS TO PROVIDE COMMENTS ON A DRAFT PLAN DETAILING THE DISTRIBUTION OF HOUSING FUNDS

THE DRAFT PLAN WILL BE OPEN FOR PUBLIC COMMENT FROM MARCH 15, 2020 THROUGH APRIL 15, 2020

A Public Hearing Will Be Held To Receive Input On The Draft Plan On March 19, 2020 From 6:30PM – 8:00PM At The Chapel Hill Public Library, Meeting Room B. Spanish Interpretation Will Be Available.

HILLSBOROUGH, NORTH CAROLINA, March 4, 2020 - The Orange County Local Government Affordable Housing Collaborative will be publishing a draft Consolidated Plan on March 15 and invite public comments on the draft from March 15 – April 15. Hard copies of the draft plan will be available at the Town Halls and a digital copy will be posted on the County website at <a href="http://orangecountync.gov/2337/HOME-Consolidated-Plan">http://orangecountync.gov/2337/HOME-Consolidated-Plan</a>. There will be an easy-to-read summary of the draft available as well.

The Collaborative will also be holding another public input session on March 19, 6:30 – 8:00 pm at the Chapel Hill Public Library, Meeting Room B to go over the draft

plan and receive feedback. Spanish interpretation will be available at the March 19 meeting.

The Consolidated Plan decides how the Collaborative allocates funding from the HOME Investment Partnerships Program (HOME) and the Community Development Block Grant (CDBG) to support community development and affordable housing initiatives. The funds originate from the U.S. Department of Housing and Urban Development (HUD), which requires the Consolidated Plan. The plan serves as an action-oriented management tool and guides federal grant spending to address housing and community development needs for low- and moderate-income residents for the next five years within the jurisdiction. The funds are broken down into the following two program categories:

- The HOME Investment Partnerships Program (HOME) is the largest Federal block grant available to communities to create affordable housing. The intent of the HOME Program is to 1) increase the supply of decent, affordable housing to low- and very low-income households; 2) expand the capacity of nonprofit housing providers; 3) strengthen the ability of state and local governments to provide housing; and 4) leverage private sector participation.
- The Community Development Block Grant (CDBG) is an annual grant to localities and states to assist in the development of viable communities. These viable communities are achieved by providing decent housing, a suitable living environment, and expanded economic opportunities for persons of low- and moderate-income.

Every year, HUD determines the amount of HOME & CDBG funds that states and local governments—also known as Participating Jurisdictions. In Orange County, the HOME Participating Jurisdiction is a Consortium consisting of Orange County and the Towns of Carrboro, Chapel Hill, and Hillsborough, with the County acting as lead entity. In 2017, the Consortium was renamed the Orange County Local Government Affordable Housing Collaborative. Based on prior funding patterns, Orange County's HOME award to average around \$400,000 each year. The Town of Chapel Hill is an

entitlement grantee for CDBG funding and receives approximately \$400,000 each year.
