- ▶ Reallocate \$169,728
- ▶ Neighborhood Revitalization to Temporary Housing Assistance

# CDBG Program Overview

- ▶ U.S. Department of Housing and Urban Development (HUD) created CDBG for the purposes of:
  - Providing decent affordable housing
  - Creating suitable living environments
  - Expanding economic opportunity
- ▶ Entitlement community designation



# CDBG National Objectives

- Benefit low/moderate income households earning less than 80% Area Median Income (AMI)
  - AMI=\$84,800
  - 80% AMI = \$67,850 for family of 4
- Aid in the prevention or elimination of slum or blight
- Meet an urgent need

# CDBG Eligible Activities



- Acquisition
- Homebuyer Assistance
- Rehabilitation
- Public Facilities
- Public Services



# Guidance from HUD In Response to COVID-19

- ▶ Reduced the public notice requirements
- ▶ Approved the use of virtual meetings
- ▶ Removed the public service limits for FY 20 and FY 21
