Re: Concept Plan Review for Aura Chapel Hill, 1000 MLK, Jr. Blvd.

We live on Huntington Drive, basically behind the proposed Aura development. We have reviewed the plan that includes over 390 new dwelling units plus commercial buildings.

We believe that this plan includes too many dwelling units. Our main concerns are with density and traffic. Currently the Azalea Estates are being built at Estes and Somerset. This will bring 151 new apartments to the neighborhood and Estes traffic. The Aura project, about one block away, would bring 390 more housing units. The traffic on Estes is already backed up. When Estes Hills and Phillips Schools dismiss there is a long line of traffic. There are times when it is impossible to exit Somerset and take a left on to South Estes. A 2019 article in the Raleigh News & Observer reported that according to town staff the N.C. Department of Transportation does not support adding a roundabout or a stoplight on Estes Drive.

We do not believe that the corner of Estes and MLK can accommodate over 390 new apartments and condos.
