Dear Mayor and City Council:

Thirty years ago my wife and I built our home in Chandler's Green. We built on a short, quiet street that had woodlands behind the houses on both sides of the street. We did have some concerns about the type of development that would eventually occur around our street, but we learned that the properties were zoned R2 and we were assured that that city council in Chapel Hill had a long history of protecting the environment, of

strictly limiting the number of trees that could be removed in any new development, and of carefully considering the effect that proposed new businesses and developments would have on the nature of life in Chapel Hill. We were moving in from out of state and sometimes heard people refer to Chapel Hill as "the southern part of heaven."

Thirty years have changed much. Two new housing developments have been built in formerly wooded areas that connected to our development. The wooded area behind the houses across the street was razed and replaced with East Chapel Hill High School. Now we're surrounded by a great deal of pavement and considerably more traffic noise. I used to jog down Sunrise Road, which intersects the entrance to our development, but, as a senior, I no longer feel safe even walking there – especially at times when people are commuting to work - or students are going to/from the high school.

Now, however, the proposed Weaver's Grove development will destroy hundreds of trees in the remaining wooded area behind our homes. It will replace wooded area, animal habitat, and natural water management with yet more pavement and the highest density development that we have yet had in the area. We simply cannot believe the current proposal includes 200 or more residences with traffic from an estimated 400 - 500 automobiles. The best that we can tell is that no one truly knows the effects of the water runoff from all the pavement in the development. No one really knows how much the destruction of such a large number of trees will do to air quality or to noise levels. No one seems to care how these will affect the quality of life either of existing residents or the people who will live in Weaver's Grove.

We definitely see the need for homes for teachers, police officers, firemen (and women) and others who are essential to Chapel Hill's future. However, the proposed density on this plot requires building homes adjacent to the I-40 corridor which is planned for widening. With the clearing of most of the trees, the noise level will be excessive and perhaps harmful to children and others living there. Therefore, we implore you to please act to reduce the effects on our neighborhood. Please do not allow the Weaver's Grove development to proceed with the proposed level of density. Please limit it to 50 to 100 homes and protect as much of the existing wooded habitat as is humanly possible.

Dear Mayor and Council Members:

As a resident of Chandler's Green, I have followed the efforts to improve the area by adding more affordable housing. I believe that my neighbors are in agreement with me in furthering this objective.

However, many neighbors have some concerns:

- 1) Several of us have responsibilities for project management and note that this has a feeling of projects that become "too big to fail". The proposal is for a massive project, so can milestones be introduced to allow project truncation before it gets out of hand, rather than find out only at the very end that this has become a disaster that the local citizens will be forced to live with while the developers take their profits and race off, never to be seen or heard from again?
- 2) Parking in the new development- It looks like there are not enough parking spaces for the residents and guests. Can this be clarified?
- 3) Traffic flow 1: The developers appear to assume that everyone will be driving to Hillsborough, instead of Chapel Hill, Durham, etc. Those driving to Chapel Hill will be tempted to cut through the Chandler's Green neighborhood to avoid stop lights at Sunrise and by the High School.
- 4) Traffic flow 2: LUPA Analysis item 4 notes that more population density means more use of public transportation and walking. There might be some increase in usage, but my bet would be on more car traffic instead.
- 5) LUPA Analysis item 3 describes transitioning and buffering. It already can be quite noisy in this area when the trees lose their leaves. It expect that this development will result in many trees being lost and more noise than proposed currently.
- 6) Trees: The developers want to keep as many trees as possible, but who will be responsible for maintaining the trees in the new development if they become a problem? When development trees get diseased, which resident will be paying \$1200/tree for removal? If not addressed, the disease eventually could travel downwind to my trees.

In summary, I have followed this aggressive development for a while, and although progress is being made, this still has the feeling of a disaster waiting to happen.
