2. Review of Conditional Zoning Application - Bridgepoint at 2214 and 2312 Homestead Road (Project 20-001)

A motion was made by Hoole to recommend approval of the Bridgepoint, 2214 and 2312 Homestead Road Development Application as the applicant was providing a meaningful amount of affordable housing (5 homes) and a significant increase from their concept plan proposal, the application proposed three and four bedroom affordable units, the market rate units are proposed to be comparable and compatible with the affordable units, and the transparency and thoroughness of the project's financial information provided in the presentation to the Housing Advisory Board; Jared Brown-Rabinowitz seconded this motion. The motion carried by a unanimous vote.

3. Review Housing Advisory Board Membership Applications

HAB members reviewed applications for the open HAB seats and asked staff to invite applicants Ehmu Ra, Susan Hunter, Frank Muraca, Mark Shelburne, and Michael Webb to attend the September HAB meeting.

4. Discuss Potential Updates to the Affordable Housing Funding Application and Review Process

Staff presented ideas for updates to the Affordable Housing Common Funding Application and Scoring Rubric. HAB members discussed staff's presentation and their thoughts on ways to improve the application and scoring rubric. Based on this discussion, staff is making these key updates, among others:

- 1. Re-including threshold requirements
- 2. Adding in more detail on project financials
- 3. Adding points to the rubric for projects requesting loans
- 4. Adding a racial equity lens to the application and rubric
- 5. Asking for more information on completion of comparable projects
- 5. Housing Updates

Staff provided affordable housing updates, including:

1. The provision of interpretation services for the September HAB meeting and the 1200 MLK development application

2. Covid-19 response efforts and the Town's allocation of significant funding for the Emergency Housing Assistance Program, over \$500,000 has been allocated; the Town has also assisted in the distribution of food to over 5,000 households, distributed 19,000 masks to vulnerable populations, and prepared multi-lingual resource guides

3. Updates on town-initiated development projects at 2200 Homestead Road and Jay Street

4. The Affordable Housing Development Reserve will launch its first round of funding applications, with applications due on Friday, October 2nd at noon

HAB Vice-Chair Seyda announced that CASA received the highly competitive Low-Income Housing Tax Credit award for the Merritt Mill affordable housing development project. The project expects to begin construction in spring 2021 and will create 48 affordable apartments in Chapel Hill and Carrboro.
