As you know, among its many positive benefits, this agreement will help transform 40-year old deteriorating buildings into state-of-the-art modern structures, deliver 200,000 SF of wet lab/office space (an \$80 million private investment), support relocating UNC Admissions to downtown, add desirable green space, and improve access to customer and employee-serving infrastructure, including parking.

This agreement is critical to the future and sustained success of our downtown and will play an important role as we rebound from the current recession and public health crisis. You have received letters of support for this project from my colleague Katie Loovis, longtime downtown champion and business owner Scott Maitland (both pasted below), and others. Today, after reviewing the agreement even more closely, we want to add two more points for your consideration:

- 1. First, *the agreement structure is well-defined and has well-managed risk*. It is clear that staff have used very conservative financial models, structured the agreement to leverage the town's self-sustaining parking revenues, and ensured that the agreement will not impact Chapel Hill's debt capacity or the Town's ability to borrow for other priorities. With your due diligence and third party review, you are meeting and exceeding your fiduciary responsibilities.
- 2. Second, as we learned during the Inter-City Visit to Bloomington, Indiana, *Town investment in infrastructure is necessary* to attract the private capital investments required for an activated and sustainable downtown and is necessary to support the office and lab space we desire. Structured parking, coupled with a strong transit system, are essential elements to attract investment and to bank the redevelopment and new development we will need to make downtown a hub for innovation and a regional employment center.

In closing, this is a *transformative agreement* that will bring to life our community's long-held vision for our downtown and accelerate our economic recovery. The team at Grubb Properties has shown again and again their commitment to our community and our values, and they have proven to be a *trusted and valued development partner*. We encourage you to vote to *approve this agreement*, move forward with the land exchanges, and make this remarkable partnership a reality.

Greetings, Mayor Hemminger and Council members:

> I am writing you with deep concern over the excessive scale of the planned parking deck and associated office building which I believe will greatly exacerbate already problematic traffic issues in the project area. I urge you to pursue more direct access to/from the new deck directly to 4-lane MLK via a previously identified corrider behind the PNC bank building as well as scaling back the size of the project to avoid downtown gridlock.

>

> Let me be clear, I agree that downtown Chapel Hill needs "a shot in the arm" and that public investment in infrastructure can be one mechanism for delivering that. Nonetheless, just like with Covid-19 vaccines, decision makers must be sure that the "shot" to be delivered to downtown with this project is both safe and effective, and does not have serious unintended consequences.

> I focus here only on the remaining issues of transportation impacts. Unfortunately, even as I write, one week from the final vote on October 28, there is no final revised TIA available to the public so I must rely on the info in the September 2020 report. But, thank you, Ms. Ryan, for your sharp eyes in detecting the error in the "growth factor" in that report which caused under estimations in traffic projections.

> It is undisputed that the intersection of East Rosemary and MLK is already congested, earning ratings of D, E and F for certain traffic maneuvers at p.m. peak, along with generating vehicular delays and long queues both east and west bound. Table 9. Even the addition of the proposed access via narrow North Street still leaves this critical intersection in worse shape in 2023 after project completion. Table 14. As far as I could tell, the narrative of the TIA does not address future traffic beyond the 2023 horizon and of course there will be other new developments down town adding to traffic issues after that. Facile assurances that somehow better traffic signaling and signage will mitigate all these problems does not put my mind at ease.

> It seems to me that a fundamental problem may be that the new project shifts the vast majority of the parking to the north side of Rosemary in the new 1100 space deck whereas currently the parking capacity is more evenly split between the north and south sides of the street. Loading so much parking capacity to one side of the street compounds the access issues significantly, especially for egress. And, the significant inherent constraints at the site, including no additional available right of way, means that no easy fixes are obvious got the proposed large-scale project.

> Speaking of egress from the new deck to East Rosemary, I urge you to take a closer look at the projections in the TIA. At present, the majority of those using all current facilities turn east when exiting at p.m. peak. Figure 5A. This makes sense to me as most population centers to which drivers are returning are to the east of Chapel Hill, including Raleigh and some of Durham. Also, living on E. Rosemary St. just west of the Hillsborough intersection, I know from personal experience that I cannot reliably turn east out of my driveway in the late afternoon due to the long queue approaching that intersection from downtown.

> Accordingly, it seems odd to me that the TIA would project that in 2023 the overwhelming majority of the cars exiting to Rosemary Street would turn west. Figure 13 A. Is this because turning east on Rosemary out of the new deck (as most drivers now do) will be near impossible given the heavy traffic coming east bound thru the intersection at MLK? And, of course, the proposed North Street egress would be of no use to drivers morning to go east from downtown. My point is that if the directional preferences of those exiting the deck are not adequately taken into account there may be much greater back up into the deck by frustrated drivers, not to mention more accidents as they persist in trying to turn left through heavy traffic on to Rosemary St.

> The best solution to all this seems to be getting the deck users more directly to and from MLK rather than using smaller streets like Rosemary and North Street. A potential access was shown through the PNC bank parking area in a preliminary site concept plan in the TIA (Figure 2A) but the TIA is silent on whether this access was evaluated, and if so, why it was not pursued.

> Finally, if a project of whatever design and scale goes forward, I plead with you to ban construction traffic from using the smaller streets like Rosemary to access the project site. All contractors should be required in the bidding process and in any construction contracts to utilize MLK as the default access, thus limiting the expected cut through traffic in nearby neighborhoods. Otherwise, the impact of the two-year+ demolition and construction process could have truly devastating effects on nearby neighborhoods, including but not limited to the Franklin – Rosemary historic district.

> Thank you for your consideration of these comments though I regret that our national crisis has prevented other
citizens from being more actively involved in this critically important decision. I also thank you for your service to our
Town.
