A RESOLUTION ADOPTING UPDATES TO THE MOBILITY AND CONNECTIVITY PLAN (2020-10-28/R-23)

WHEREAS, the North Carolina Department of Transportation (NCDOT) adopted a Complete Streets Policy in August 2019 requiring that NCDOT pay for bicycle, pedestrian, and transit facilities as part of major roadway construction projects, if they are in adopted plans; and

WHEREAS, the Town of Chapel Hill Mobility and Connectivity Plan, adopted in October 2017, recommends a Town-wide network of connected bicycle and pedestrian facilities, and is a component of the Town's Comprehensive Plan; and

WHEREAS, the proposed updates to the Plan are primarily limited to facilities along NCDOT-maintained roads and are intended to position the Town to take maximum advantage of the NCDOT Complete Streets Policy; and

WHEREAS, the Plan updates also include minor realignment of the multiuse path network in the northwest corner of Town, enhancements to Chapel Hill Transit stops, and the NC 54 Pedestrian and Bicycle Corridor Safety Study.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Town of Chapel Hill that the Council adopts the proposed updates to the Mobility and Connectivity Plan.

BE IT FURTHER RESOLVED that the updates are contained within the revised comprehensive Mobility and Connectivity Plan, and include enhanced bicycle and pedestrian facilities on NCDOT-maintained roads (as referenced in Attachment A to this resolution), the NC 54 Pedestrian and Bicycle Corridor Safety Study (Appendix E of Mobility and Connectivity Plan), and a map showing Chapel Hill Transit bus stop improvements (Appendix F of Mobility and Connectivity Plan).
