I am sure council members feel relief that the FLUM is wrapping up. We offer two comments on the final draft.

First, we call on the Council to develop a gateway/entranceway plan for 15-501 north, and South Columbia to the south. Entranceways were once an integral part of Chapel Hill's Comprehensive plan through the 1980's and 1990's, but were lost entirely when the most recent comprehensive plan was adopted.

When the Council begins the Phase 2 study of the Southern entranceway, it is essential that the Council ensure that future zoning retains our college town character, and that the Town directed study evaluates whether the four story structures now proposed for the So Columbia neighborhood can actually be supported by safe transportation, can meet Town stormwater and environmental standards, and most important, retain existing affordable housing in the Purefoy neighborhood.

Finally, the world in two years from now will look very different than it did before COVID and the Council will want to revisit this plan to adjust for changed conditions.
