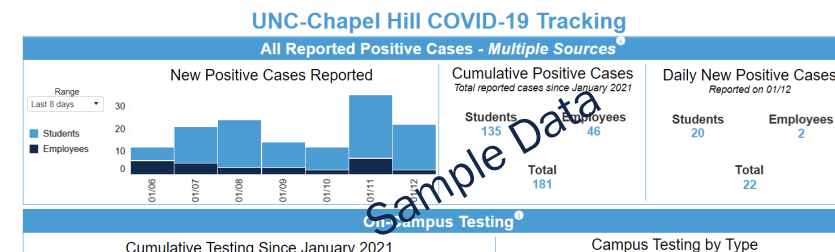
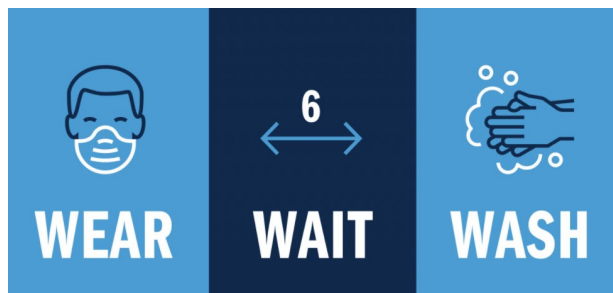


- Undergraduate Classes begin Jan 19th

- Re-entry and Regular COVID-19 Evaluation Testing
- Campus Health Testing
 - Symptomatic & close contact testing for students
 - Testing Response Teams for on location testing in Campus/Greek Housing
 - Rapid molecular testing now available
- Carolina Together Testing Program
 - Free, asymptomatic testing for students and employees
 - Locations: Carolina Union, CURRENT Art Space, & Rams Head Recreation Center
 - Volunteer core of 450 student volunteers.

4	Graduate and Professional Students, Post-Doctoral Fellows*	Living in Chapel Hill or Carrboro not in Group 3 or not accessing campus OR Living in Chapel Hill or Carrboro but not accessing campus			 Once a Week	
5	Faculty and Staff#	Accessing campus			 Once a Week	 Daily
6	Faculty and Staff	Working remotely and not accessing campus
