## **2.** Aura Conditional Zoning

[21-0171]

HAB members expressed their appreciation for the applicant's commitment to providing 15% of the units as affordable, the rental units were floating throughout the site and were of a similar size to market rate units. The HAB also asked questions about where the affordable homeownership units would be located and how they would be built, whether parking could be unbundled, and how compliance with affordable housing commitments would be monitored and enforced.

Members of the public expressed concerns the traffic the project would create, that the development isn't transit oriented, and would like for the project to supply something neighbors would walk to.

A motion was made by Vice-Chair Mills, seconded by Shelburne, that the Aura Development Application be recommended for approval. The motion carried by a unanimous vote.

## 3. University Place Special Use Permit Modification

[21-0172]

HAB members expressed their belief the project follows the Town's affordable housing ordinances, an interest in seeing reduced minimum parking requirements, and unbundled parking if there are for-sale units.

A motion was made by Shelburne, seconded by Hoole, that the University Place application be recommended for approval. The motion carried by a unanimous vote.

Key points made by members of the Housing Advisory Board during its review of the concept plan include:

· The affordable housing proposal is an interesting idea, but could be

difficult to identify which property the contribution would work for
 If the affordable housing proposal does not end up working, could consider using some units for Housing Choice Voucher holders

#### **6.** Annual Priorities Discussion

A motion was made by Hoole, seconded by Vice-Chair Mills, that the following priorities be approved. The motion carried by a 4-1 vote with Shelburne voting against.

#### **HAB Priorities:**

- 1. Focus on assisting the Town in updating its land use and affordable housing policies to better address the housing needs of the community.
- 2. Include a focus on communication and engagement with the residents and advocates living in affordable housing.
- 3. Strategic development of the HAB's expertise on affordable housing at least quarterly.

The HAB plans to have further conversation on which policy areas to focus their land use and housing policy recommendations.
