Chapel Hill North is quite congested and this speaks to the need to preserve our natural woods. Take a walk in the Greene Tract and you will see such beauty that many of the residents in Chapel Hill enjoy daily either by walking or biking. Particularly during the time of COVID, the need for nature, space, separation, hiking, biking has never been more critical and obvious. There will not be an opportunity to get this beautiful space back once it is sold or developed. The great trees of the Greene Tract are breathtaking and should be preserved. I do think there could be an opportunity for allotment of some of the Greene Tract to affordable housing without destroying a large area of contiguous woods as has previously been presented.

I am writing pertaining to the vote that will occur tonight on development plans for The Greene Tract Forest. Per the available materials it appears that all alternatives currently under consideration include paving and widening ALL the current double track trails on the property into an extensive road system that divides the land into 4-5 separate parcels. Based on this information it appears that NOT ONE of these parcels are designated to be fully preserved with only small areas of wetlands marked as protected.

My understanding was that there was a commitment to conserving $\sim\!80\%$ the beautiful natural resources on this public property with $\sim\!20\%$ designated for affordable housing. These plans appear to ignore any sort of conservation commitment previously stated.

The Greene Tract Forest is an important recreational resource for our community now and for future generations. Preserving small areas of wetlands surrounded development does not allow for an actual park that can be used by the community.

The Greene Tract presents our community with an opportunity to build REAL affordable housing (not market value housing) and create a REAL park addressing two needs of our community.

Please reconsider the proposed plan for this land and lets work together as a community to design a plan for affordable housing and a park.

The Greene Tract has been a refuge for my family and friends. We use the trails to hike, walk, run, walk the dogs, and bike. During the pandemic I have seen the number of people using the trails increase as people have sought out ways to be outdoors.
