Specifically, I wish to help balance the goal of promoting the vitality and continuous renewal of the historic districts with the goals of preserving historically significant buildings and settings and ensuring that changes to structures and streetscapes within a given district are in harmony with the district's character. I am lifelong resident of Chapel Hill and graduate of UNC-CH and have lived in both the Franklin-Rosemary and the Cameron-McCauley districts. I will bring to my work on the Commission extensive knowledge of Chapel Hill's history, a strong appreciation for and desire to perpetuate the Town's distinctive cultural heritage, experience using the tools of zoning and design standards to conserve neighborhood character, three years of experience serving on the HDC-two of them as Chair —and a commitment to working collegially with fellow HDC members and constructively and respectively with district homeowners. My contributions during my first term on the HDC, beyond attendance at regular monthly meetings and participation in quasi-judicial review of COA applications, include 1) helping guide the commission through the process of updating the Town's Historic District Design Standards and 2) working with Town staff to better align the sections of the Town LUMO that govern HDC procedures with the statute language recommended by the State Historic Preservation Office. These efforts, by bringing greater clarity and consistency to the relationship between the LUMO, the Design Standards, and the process of COA review, will, I believe, enhance public understanding of and support for the work of the HDC and reduce conflict between the HDC and district homeowners. Finally, my term as Chair coincided with the COVID-19 pandemic. I have worked during this period with my fellow commissioners and with Town staff to maintain the HDC's ability to function effectively under challenging conditions so that district homeowners could proceed with their renovation and new construction projects.
