In response to the Town Council's request and on behalf of the Stormwater Management Utility Advisory Board (Board), I present comments concerning the 101-111 Erwin Road Conditional Zoning application for your consideration.

The Board held a virtual meeting on Tuesday, June 22, 2021 and received a presentation from the applicant and heard input from residents. The Board acknowledges the project meets the Town's stormwater management regulations and the peak flow reductions being proposed by the applicant. The Board prepared comments, which are included below.

The Stormwater Management Utility Advisory Board (Board) recognizes the continuing flooding concerns experienced by residents in the adjacent Summerfield Crossing neighborhood.

The Board requests the Town Council to allow additional analysis of the applicant's proposal to add a swale or pipe in the 100-foot perimeter buffer. This solution could divert the runoff away from the ephemeral channels along the shared property line and alleviate some of the flooding issues experienced by Summerfield Crossing residents, while still maintaining a vegetated buffer that screens the hotel from the neighborhood.

The Board also recommends an analysis of additional volume reductions through appropriate plantings and other measures.

A motion to approve these recommendations was made by Mr. Post; Mr. Wang seconded the motion. In a roll call vote, the motion was approved unanimously (7-0).
