Villagran shared concerns about pedestrian access and infrastructure at the intersection of Ephesus Church Road and Legion Road, including a lack of

crosswalk markings and difficulties in accessing transit. Staff noted that they would bring the issue to the weekly staff bike/ped meeting to assess solutions.

Abija brought a petition before the board to discuss concerns with Chapel Hill Transit bus service and the issues encountered by users, especially UNC students. The board discussed the importance of bus service, concerns about transit issues, and potential solutions.

TCAB voted to urge Chapel Hill Transit to do whatever is necessary to improve bus service, including utilizing drivers for the UNC student population. The board also expressed support for Abija to bring TCAB's concerns to the Chapel Hill Transit Partners committee meeting on August 31st.
