Conditional Zoning Application for Barbee Chapel Apartments

[22-0935]

The Board received the applicant's presentation and asked a series of clarifying questions about the following topics: impervious surfaces, tree protection, parking ratios, all-electric design, HVAC equipment, stormwater management, and native landscaping.

There were no public comments.

A motion was made by Member Vanderkamp, seconded by Member Gaitens-Arneson, that the Council approve the conditional zoning application for Barbee Chapel Apartments with the following conditions and special considerations:

Conditions:

- All trees and other plantings should be native
- Protect all "tree-save" areas as shown in the original plan set

Special Considerations:

- Move toward the minimum allowable parking
- Look for ways to mitigate the 50-year flood event
- Structures should be solar-ready
- More covered bike storage
- Design, at minimum, for level 1 EV charging for each unit with a designated parking space

Conditional Zoning Application for 2217 Homestead

[22-0936]

The Board received the applicant's presentation and asked a series of clarifying questions about the following topics: irrigation, induction ranges, stormwater management, trail connections, pervious pavers, tree-save areas, and wetland plantings.

Public comments were made by Derek Ross, Kamim Kasrawi and Nancy Oates. Derek Ross shared that the TCAB recommended that the Kipling connection be emergency access only, talked about the history of stormwater impacts to the Courtyard at Homestead, expressed concern that the grading along the property line could affect the existing mature trees in that area, and advocated for the tree-save areas to be made a condition of approval.

Kamim Kasrawi talked about the grading plan for the southern edge and the need to address the increased height and slope as they relate to drainage patterns. Additional interests included the Courtyard at Homestead HOA's ability to maintain the existing pond if there are any additional drainage impacts and the need to preserve existing trail connections. The applicant shared that stormwater runoff will be less than what it is today and that the trail connections will not be impacted by the project.

Nancy Oates asked if the applicant could consider installing a drain to catch the runoff along Kipling Lane before it reaches the Courtyard at Homestead and expressed the interest to preserve the mature trees along the southern border of the site.

A motion was made by Member Klakovich, seconded by Member Vanderkamp, that the Council approve the conditional zoning application

for 2217 Homestead Road with the following conditions and special considerations:

Conditions:

- All trees and plantings should be native
- To the greatest extent possible, preserve the mature trees that currently exist along the western buffer

Special Considerations:

- · Allow existing trail along Kipling Drive per UNC's wishes
- Mr. Derek Ross' letter to the Environmental Stewardship Advisory Board
