2. LUMO Rewrite - Draft Focus Area Map & Principles

Alisa Rogers, Town Staff, presented on the LUMO Rewrite. In April 2017 Town Council initiated a project to re-write the Town Land Use Management Ordinance (LUMO). Phase I is updating portions of the Future Land Use Map (FLUM), which includes six focus area. Phase II is designated to re-write the current LUMO.

The FLUM focus areas were identified based on vacant land, underdeveloped sites, and proximity to major transportation and transit corridors. Through extensive public engagment, community priorities emerged the importance of great streetscape designs, promotion of a mature treet canopy, awareness of sensitive transitions between different land uses and buildings, support environmental sustainability and resiliency, and plan for multi-modal connectivity.

The advisory board inquired if the future land use map addresses how infrastructure changes will be supported and financed.

Next steps are to continue to engage the community, host a Drop-In Session on November 6th at the Courtyard Chapel Hill, and return to Town Council on November 20th with results of Fall engagement.

3. Fordham Boulevard Sidepath Project

Bill Webster, Town Staff, summarized the inputs from the Fordham Boulevard Sidepath public meeting, which was held on September 18th. Four alternative design options were offered and the attendees were encouraged to provide input on. Approximately 60 comments were received.

Members of the public provided additional inputs. The advisory board inquired of the trade-offs and neighbood impacts of each design alternative options.

Next steps are for Town staff to meet with senior management and recieve guidance. Webster added that the Fordham Boulevard sidepath is not a

standalone project, but will be crucial in building a connected multimodal network.

4. Bollards on the Greenways

Bill Webster, Town Staff, presented the case for the removal of bollards on the greenways. Webster stated it was standard practice to install bollards at the entrances of all greenway trails and sidepath. Reasons for installing bollards were to prevent larger motorized vehicles and motorcyclists from accessing trails. After removal for maintanence, bollards have been left on the trail and are dangerous for bicyclists and pedestrians.

Webster asked the advisory board to consider whether or not to install bollards at trail and greenway entrances. Rare incidents of motorized vehicles travelling on the greenways or trails. Webster offered that the town could deviate from standard practice by being selective of where bollards are installed and remove the center bollard while retaining the side bollards.

John Rees, Planning Commission Liaision, noted the town was not consistent with bollard installations. Kastrinsky inquired if the Town would take into account the legal obligation of removing bollards and any potential negligence if the center bollard was not properly removed and path smoothed out.

Next steps are to consult the Town attorney on legal matters relates to removing the center bollards from the greenway and trail entrances.

4.1 US 15-501 Corridor Study - Alternative Designs

Jomar Pastorelle, Town Staff, summarized the US 15-501 Corridor Study public meeting, which was held on October 17th. Staff from Durham-Chapel Hill-Carrboro Metropolitan Planning Organization (DCHC MPO) and the consultants - WSP hosted the event. Approximately 60 people, including Durham staff, attended to provide input on the three proposed alternative design concepts.

Pastorelle displayed each alternative design concept. The advisory expressed what are the next steps to communicate their concerns on proposed concept plans. Staff recommended the board to continue to provide comments. DCHC MPO staff will attend the November 26th meeting to discuss the concepts and

accept input.
