a. Review the Bridgepoint development application and make a recommendation for Council

A motion was made by member McClintock, seconded by member Henkel, that the application for the Bridgepoint project, located at 2214 and 2312

Homestead Rd, be recommended for approval with the following special considerations.

- Have the project reviewed by the Stormwater Utility Advisory Board
- Include native and non-invasive plantings only
- A/C SEER rating of 16 or greater for all homes
- Solar ready rooftop design, including wiring

### Condition:

-If the project receives the exemption requested for encroachment into the RCD, the following recommendation holds

**Special Considerations:** 

- Request that the Stormwater Utility Advisory Board make recommendations on the applicant's proposal for stream restoration, including more details about flora and fauna
- A traffic study with particular attention to carbon impacts from vehicle idling, as well as commuter traffic and congestion

Have the project reviewed by the Stormwater Utility Advisory Board

- Because an all-electric building is proposed, strong consideration must be given to installing a rooftop solar PV system
- Comply with the Transportation and Connectivity Advisory Board's recommended guidance for EV stations
