a) 101-111 Erwin Road - Conditional Zoning

The applicant presented an overview of the project, including information about the Board's development review criteria. Board members asked clarifying questions about stormwater management, the existing pond, energy management in building design, steep slopes and neighboring development.

Grace Elliott left the meeting.

One member of the public indicated that the applicant's proposed solution for minimizing off-site stormwater impacts sounds good, but that they still have concerns because their adjacent neighborhood (Summerfield Crossing) has a lower water table. The applicant expressed optimism that by continuing to work with the Stormwater staff and Summerfield Crossing, a solution could be found. The applicant also noted that a second visit to the Stormwater Utility Advisory Board is scheduled for later in the month.

A motion was made by Member Vanderkamp, seconded by Member Myers, that the Residence Inn-Summit located at 101-111 Erwin Road be recommended for approval with the following conditions and special considerations. The motion carried by the following vote. Subsequently, Julie McClintock left the meeting.

CONDITIONS

 Request that the Applicant return to the Stormwater Utility Advisory Board and review the currently proposed solutions, as well as the modifications proposed

- Regarding the stormwater management plan for the construction phase, ask
 Orange County to consider a storm event greater than 100 years for the erosion control permit
- For analysis point #2, reduce the stormwater peak flow rate to no less than 50% for all storm events without Christ Community Church and for no less than 85% with Christ Community Church
