#### 4. HAB Member Training: Tax Credit 101

Dustin Mills, HAB Vice-Chair and President of Taft-Mills Group, gave an overview presentation about the Low Income Housing Tax Credit Program. The presentation relates to one of the HAB's 5-Year Priorities related to increasing the technical expertise of its members.

#### **5.** Discussion of Town Resources for Affordable Housing

A motion was made by Chair Hunter, seconded by Hoole, that the HAB support the Orange County Affordable Housing Coalition's recommendation that the Town Council increase the dedicated source of affordable housing funds in the FY2023 budget to two pennies on the tax rate. The motion carried by a unanimous vote.

#### **6.** Recommendations to Council for Open HAB Seats

The HAB conducted a ballot vote to determine their recommendation to Council for appointment of the Tenant or Homeowner seat and the For Profit Developer seat. The HAB voted unanimously to re-appoint Rex Mercer to the Tenant or Homeowner seat and Dustin Mills to the For Profit Developer seat.

A motion was made by Dowling, seconded by Hoole, that the HAB accept the results of the vote and recommend that the Town Council re-appoint Rex Mercer to the Tenant or Homeowner seat and Dustin Mills to the For Profit Developer seat. The motion carried by a unanimous vote.

## 7. Consideration of Policy Update for Advisory Board Remote Participation

A motion was made by Hoole, seconded by Chair Hunter, that the Council approve the Advisory Board Remote Participation Policy Update to allow advisory boards to continue to have the option to meet virtually. The motion carried by a unanimous vote.
