**RECOMMENDATION:** The Community Policing Advisory Committee met on Tuesday, June 12th, 2018 and by a unanimous vote have made the following recommendation(s) to the Town Council for consideration:

**SPECIAL REQUEST(S):** No Comment

**BACKGROUND:** The Community Policing Advisory Committee currently has for 3 vacancies due to terms expiring in June of 2018. Additionally, we have one vacancy due to the resignation of Caleb Harrison. Mr. Harrison moved and was unable to fulfil his term that was scheduled to end in June of 2020. The Community Policing Advisory Committee has recommended the reappointment of 2 members and the addition of two new members to fill all of our vacancies.
