 - What would be the vision for such a venue? What types of programming would be appropriate and desired by our community?
 - O How would such a venue meet community needs, reflect community values, and attract a wide range of individuals to the Downtown and what would be the economic impact on the Downtown?
 - What would be the costs of this conversion for both acquisition and necessary refurbishment - and how long would it require? How would these costs be paid for and what kinds of partnership(s) might be feasible?
 - What would be the business model of the new entity in terms of ownership, ongoing management, and ability to be financially secure and self-sustaining?
- That following the task force's report to the Council in May 2019, the work of the task force will be deemed complete and the task force will be discharged

Key Issues:

- The Varsity Theater is located at 123 East Franklin Street and has served as a movie theater since the Sorrell building was built in 1927. The owners of the Varsity Theater indicate that it may be up for the sale in the near future. At the same time, there is an expressed need and desire for public spaces and infrastructure devoted to cultural arts.
- Town of Chapel Hill and Orange County staff will partner on the process by preparing for meetings and gathering and providing information for decision-making. Staff members Susan Brown (or designee), Town of Chapel Hill, Katie Murray, Orange County Arts Commission, and Laurie Paolicelli, Chapel Hill Orange County Visitors Bureau, will be assigned as liaisons between the task force and Town and County staff.

Fiscal Impact/Resources: No fiscal resources are required to establish this process, with the exception of staff resources.

A RESOLUTION ESTABLISHING A COUNCIL TASK FORCE TO CONSIDER THE POSSIBLE USE OF THE VARSITY THEATER AT 123 EAST FRANKLIN STREET AS A COMMUNITY PERFORMING ARTS CENTER (2018-10-24/R-3)

WHEREAS, the Council has an interest in enriching the cultural arts in Chapel Hill and enhancing the social and economic vitality of our Downtown; and
