BE IT RESOLVED by the Council of the Town of Chapel Hill that the Council hereby adopts the following resolutions and ordinances as submitted by the Town Manager in regard to the following:

- 2. Temporarily Suspend Certain Ordinances and Authorize the Town Manager to Continue Temporary Measures to Aid Retail and Restaurant Use during the COVID-19 Pandemic State of Emergency. (O-1)
- 3. Approve an Affordable Housing Funding Request from the Compass Center. (R-2)
- 4. Call a Public Hearing for November 4, 2020 to Consider Annexing Property at 7000 Millhouse Road. (R-3)
