RECOMMENDATION: The Chapel Hill Downtown Partnership met on Thursday, May 10, 2018, and by a unanimous vote have made the following recommendation to the Town Council for consideration:

- Mimi Hock, Appointment, Town Appointed Seat/Downtown Property Owner

BACKGROUND: The Board of Directors for the Downtown Partnership are excited for Mimi Hock to be appointed to the Board as a property owner representative in the downtown business district. Mimi brings a truly unique perspective to the organization that is rare to replicate; she is a downtown property and business owner, as well as a downtown resident.
