- Resident seat - Noel Myers (preference), Ivan Arrington (first alternate)
 - The Board recommended Noel Myers for his professional expertise in the field of renewable energy, which they also recognize as being an important Town priority. They also valued Noel Myers' commitment to return to the Town after serving previously.
