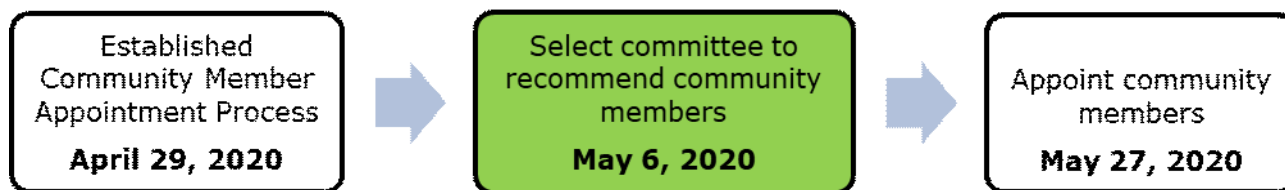
Recommendation(s):

A RESOLUTION TO ESTABLISH A COUNCIL COMMITTEE TO RECOMMEND COMMUNITY MEMBERS TO PARTICIPATE IN THE TOWN ATTORNEY ASSESSMENT CENTER (2020-05-06/R-6)
