**Overview:** On May 29<sup>th</sup>, 2020, the Town received an allotment of \$746,410 from Orange County for the <u>Coronavirus Relief Fund <https://home.treasury.gov/policy-issues/cares/state-and-local-governments></u> (CRF). This funding is part of the larger federal economic relief package known as the Coronavirus Aid, Relief, and Economic Security (<u>CARES <https://home.treasury.gov/policy-issues/cares/state-and-local-governments></u>) Act. The CRF provides financial resources to state, local and tribal governments to help navigate COVID-19. See the attached Staff Report for additional details about funding categories, possible expenses and anticipated amounts.


#### Recommendation(s):
