- 2. Approve the Miscellaneous Budget Ordinance Amendment to Adjust Various Fund Budgets for FY 2020-21. (O-1)(O-2)(O-3)(O-4)
- 3. Authorize the Town Manager to Submit Public Comments to the North Carolina Utilities Commission Concerning Duke Energy's 2020 Integrated Resource Plan. (R-2)
- 4. Continue the Public Hearing for a Conditional Zoning Application for Columbia Street Annex, 1150 S.
