**Overview:** The Council established the Criminal Justice Debt Program (CJD P) as a one-year pilot. In February, the Council amended the eligibility requirements and added a mechanism to include residents from the Town of Carrboro to participate in the program. The CJD P Advisory Committee facilitates this program, and the members' terms expire on April 22, 2021. This item would continue the program/members' terms through the next fiscal year.
