Rosemary Street and 208 Pritchard Avenue. The Council continued the legislative hearing to October 13, 2021. On October 8, 2021, the applicant requested that this item be continued from the October 13, 2021, meeting to the November 10, 2021 meeting. The applicant provided an updated site plan on October 20, 2021, which required additional review by Town staff. Staff recommends that Council defer consideration to November 17, 2021.

WHEREAS, on November 10, 2021, staff requested that the item be continued to the November 17, 2021, meeting.
