Fiscal Year 2022 Annual Report Highlights:

Community Indicators

- The median household income for the Chapel Hill Metropolitan Statistical Area was \$86,400, a decrease of \$4,000 (or 5%) from FY21.
- The median home value was \$486,733, an increase of \$76,000 (or 19%) from FY21.
- The percentage of cost-burdened renters stayed stable compared to FY21 data at 57% of renters currently spending more than 30% of their income on housing expenses.

Affordable Housing Results

- 123 affordable units approved by Council, including 102 in Town-initiated projects on Townowned land
- \$2.5 million awarded to community partners for affordable housing projects

- 105 new development units awarded funding from the Town
- Enhanced the Employee Housing Program, providing our first Homebuyer Assistance award to a Town employee
- Collaborated with local governments to create Manufactured Home Action Plan
- 492 households provided with Emergency Housing Assistance
